Checking Accounts.**

Our current check processor, Travelers, will no longer be a share draft processing center. The routing number for your checking accounts at PHI Federal Credit Union has changed. The new routing number is 265281965. If you have not received your new checks, please contact the credit union. Please begin using your new checks as soon as you receive them. All checks received with the old routing number will be returned “Refer to Maker—Unable to Process” after October 30, 2009. If you have direct deposit from company’s other than PHI, Inc., Acadiana Bottling Co, Rig Fab or Red Fox, please notify them immediately with the new information on your new checks. The same goes for any direct debits, such as insurance, mortgage payments, etc. you may have with any creditors. If you any questions, please do not hesitate to call the credit union.
